- 3 1. The Court grants preliminary approval and conditional certification of the Class;
- 4 2. The Court grants preliminary approval of Plaintiff Jonathan C. Hernandez as Class
- 5 Representative;
- 6 3. The Court grants preliminary approval of Otkupman Law Firm, A Law Corporation, as
- 7 Class Counsel;
- 8 4. The Court grants preliminary approval of a settlement of claims as set forth in the
- 9 Settlement Agreement;
- 10 5. The Court approves the proposed Class Notice and Exclusion Form;
- 11 6. The Court grants preliminary approval of Simpluris Inc. as Claims Administrator and
- 12 payment of service in the amount up to thirty five thousand dollars (\$35,000.00);
- 13 7. The Court grants preliminary approval of the payment of service to Plaintiff Jonathan C.
- 14 Hernandez in the amount up to five thousand dollars (\$5,000.00).
