21 of the above-captioned court on the motion for an order granting an award of attorney's fees and
22 costs to Class Counsel. Attorney Amy R. Lovegren-Tipton appeared on behalf of Plaintiff and
23 the settlement class. Attorney Kathy Le appeared on behalf of Defendant. The Court has
24 reviewed the papers filed in support of the Motion, including the *Amended Joint Stipulation for*
25 *Class Action Settlement* ("Settlement Agreement") and the exhibits thereto and briefs and
26 supporting declarations. The Court has also considered the objections, if any, presented by the

Plaintiff settlement class orally or in writing. Based on the oral and written argument and evidence presented in connection with the motion, the Court makes the following findings:

A. The Court approves an award to Class Counsel for attorney's fees in the amount of \$29,997.00 and costs in the amount of \$4,165.00. The Court finds that this award is appropriate given 1) the contingent nature of this action; 2) the novelty and difficulty of the questions involved; and 3) the results obtained for the Plaintiff and the settlement class.

Based on the foregoing finding, and good cause appearing:

IT IS HEREBY ORDERED, ADJUDGED AND DECREED:

That class counsel shall be paid from the Gross Settlement Amount the sum of \$29,997.00 for attorney's fees and \$4,165.00 for costs.


