

Why am I receiving this notice? A settlement has been reached in a class action lawsuit concerning a November 25, 2023, targeted cyberattack against Quaker Window Products, Co. ("Quaker") in which private information were accessed. Quaker denies that it did anything wrong, and the Court has not decided who is right. The parties have agreed to settle the Lawsuit ("Settlement") to avoid the risks, disruption, and uncertainties of continued litigation. A copy of the Settlement is available at www.QWPDataSettlement.com.

Who is included in the Settlement? You are included in the Settlement Class if you received a Notice Letter from Quaker notifying you that your private information was compromised in the cyberattack.

What are the Settlement benefits? (1) All Class Members may claim two years of Identity Theft Protection Service, with up to \$1 million of identity theft insurance. (2) Class Members who spent at least one hour responding to the Data Incident may claim up to 4 hours, at \$17.50/hour, for lost time. (3) Class Members who incurred out-of-pocket expenses and/or suffered an actual monetary loss, may submit claims for reimbursement; requirements and instructions may be found at www.QWPDataSettlement.com.

How do I receive a benefit? To claim the Identity Theft Protection Service and/or Reimbursement for Lost Time, simply complete the attached Claim Form, tear at perforation, and return by U.S. Mail. Postage is already paid. To submit all other claims, visit www.QWPDataSettlement.com or call (866) 675-2751. **Claims must be submitted online or postmarked by April 10, 2025.**

Who represents me? The Court has appointed Millberg Coleman Bryson Phillips Grossman, PLLC, Markovits, Stock, & DeMarco, LLC, Stranch, Jennings, & Garvey, PLLC, Federman & Sherwood, Chestnut Cambronne, PA, and Strauss Borrelli, PLLC, to represent you and the Class ("Class Counsel").

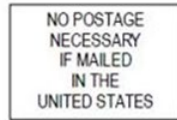
What if I don't want to participate in the Settlement? If you do not want to be legally bound by the Settlement, you must exclude yourself by **March 11, 2025**, or you will not be able to sue Quaker for the claims made in *this* lawsuit. If you exclude yourself, you cannot get benefits from this Settlement. If you want to object to the Settlement, you may file an objection by **March 11, 2025**. The Settlement Agreement, available on the Settlement website at www.QWPDataSettlement.com, explains how to exclude yourself or object.

When will the Court decide whether to approve the Settlement? The Court will hold a hearing in this case on **April 2, 2025**, at the **Osage County Circuit Court, 106 E Main St, Linn, MO 65051**, to consider whether to approve the Settlement. The Court will also consider Class Counsel's request for \$175,000 to cover attorneys' fees and costs of litigation, \$1,200 service awards for each of the Class Representatives, and \$20,886 for the costs of administering the Settlement. You may attend the hearing at your own cost, but you do not have to.

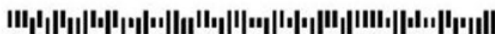
